Minimum Work experience of similar size and nature: **NRs. 2,75,00,000.00 without VAT**

If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. 5000. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np).
