- 5. Bidder shall have the option of submitting their bid electronically only. Submission of Hard copy bids shall not be entertained.
- 6. Electronic bids must be submitted to the office or through PPMO website www.bolpatra.gov.np/egp on or before

12:00 on 2076.11.15. Bids received after this deadline will be rejected.

- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend *at 14:00 hours* on 2076/11/15 at the Jayaprithvi Municipality, Chainpur, Bajhang. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If Bidder wish to Submit the bid security in the form of cash bidder has to deposit cash in Dharauti Account no 4110303007113 of Jayaprithvi Municipality, Chainpur, Bajhang at Rastriya Banijya Bank Bajhang Branch, Bajhang and Submit Bank Deposit Voucher along with a Bid.
