Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Na Pa Kosh Khata as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Sealed or electronic bids must be submitted to the office **Jayaprithvi Municipality, Bajhang** by hand/courier or through PPMO website www.bolpatra.gov.np on or before **12:00 Noon on 2073/12/15**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2073/12/15** at the Jayaprithvi Municipality Office, **Bajhang**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRS. 2,50,000.00** which shall be valid for 30 days beyond the validity period of the bid.
